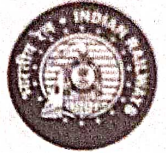


The above named employees are not eligible for all facilities on transfer accounts.

Fixation of pay will be done as per extant rules on the subject employee is eligible to exercise an option within a period of one month for fixation of pay on promotion in the matter as laid down in RB's Ltr No. E(E)II/89/FR-1/1 dt. 12/12/1991 Amendment to the IREC Vol.II(VI Edition 87). However he has already awarded higher grade under MACP scheme not entitled for pay fixation on his regular promotion as it is the same grade granted under MACP reference to para 4 of annexure of Railway Board's letter No. PC-5/2009/ACP/2 dated 10.06.2009.

Transfer of Railway servant, ordered as result of his promotion should be carried out by the employee as early as possible in his own interest. in the case of an employee who neither gives the refusal in writing not joins duty on being promoted, it should be treated as refusal of Promotion and action taken accordingly, it is responsibility of controlling supervisor to inform the concerned staff accordingly and get it noted.
