Sr. No. 2 has been promoted as Tech Train Light Fitter Gr. I on proforma basis w.e.f. 04.05.2020 i.e. from the date his junior promoted and on actual basis from the date of issue of order. Since he was under going effective punishment " Reduction in the same time scale of pay by 3 stages for a period of 1 year, without cumulative effect was imposed dtd. 11.01.2021.


Sr. No. 1 is not eligible for any facilities on transfer account.

The above promotion order is provisional and subject to the condition that there are no DAR/SPE/VIG cases pending and they are not under going any penalty debarring promotion which should be ensured by the supervisor/official concerned before the promotion is effected.

The promotion is also subject to disposal of writ petitions/appeal/applications pending in Honorable Supreme Court/High Court or CAT as the case may be. The employee is eligible to draw higher rate of pay in the promoted grade from the date they shoulder higher responsibility

If the employee desires to fix their pay considering the annual increment of lower grade on promotion, he should submit his option to that effect within one month from the date of issue of office order. Option received after one month will not be considered. However it is advised that those who have already awarded GP 4600/- under MACP scheme are not entitled for pay fixation on their regular promotion as it is the same grade pay granted under MACP in reference to para 4 of annexure of Railway Board's letter no.PC-5/2009/ACP/2 dated 10.06.2009. The date of shouldering higher responsibility of the employee should be advised to all concerned without fail.
