Fixation of pay will be done as per extant rules on the subject. Employees are eligible to exercise an option within a period of one month for fixation of pay on promotion in the manner as laid down in RB's LtrNo.E(E)II/89/FR-1/1 dt.12/12/1991- Amendment to the IREC Vol.II(VI Edition 87). However, they have already awarded higher grade under MACP scheme are not entitled for pay fixation on their regular promotion as it is the same grade granted under MACP in reference to para 4 of annexure of Railway Board's letter no.PC/5/2009/ACP/2 dated 10.06.2009.


Transfer of a Railway servant, ordered as a result of his promotion should be carried out by the employee as early as possible in his own interest.
