No. PC – 5/2009/ACP/2 dtd. 10/06/2009. Option once exercised shall be final.

It is the responsibility of controlling supervisor to inform the concerned staff accordingly. The date of shouldering higher responsibilities of the employee should be advised to all concerned without fail.

The promotion is also subject to disposal of Writ petitions/appeals/applications pending in Honorable Supreme Court / High Court of various CATs as the case may in occupation before carrying out the transfer / promotion order.
