OFFICE ORDER NO 598/2021

Sub : Coverage under Railway Services (Pension) Rules, 1993, in place of National Pension System, of those Railway Employees whose selection for appointment was finalized before 01/01/2004 but who joined Railway services on or after 01/01/2004 but who joined Railway service on or after 01/01/2004.

In terms of RBE No 28/2020 dated 03/02/2020 & RBE No 84/2020 dated 30/09/2020, the following employee, who has fulfilled the terms and conditions laid down in the DOP & PW's O.M. No 57/04/2019-P&PW(B) dated 17/02/2020 and submitted his option before 31/05/2020, is switched over from New Pension System scheme to Railway Services (Pension) Rules 1993 vide Office Order No 482/2020 dated 04/11/2020. As per Dy.CPO(NG)CSMT's letter referred at 3), with the approval of Competent Authority Office Order No 482/2020 dated 04/11/2020 was cancelled. Now as per Railway Board and CPO(Admn)CSTM's letters referred at 4) & 5) the candidates selected through CEN 01/2002 may be considered their option to switching over to Old Pension System from NPS. Accordingly the following employee is switched over from New Pension System scheme to Railway Services (Pension) Rules 1993 (OPS).
