**OFFICE ORDER No 02/2022**

Sub- Re instiation order in f/o Shri Nilesh Laxman Maske, ex.LPG/PB to LPS/PB in Level-4

As per Sr DME/SUR's letter No SUR/M/173/L/SPAD/2021 dated 04/10/2021, while working as LPG Shri Nilesh Laxman Maske has been removed from Railway Service with immediate effect

On appeal ADRM/SUR vide letter dated 23/12/2021 has reduced the penalty as under-

"Reduction to initial stage of Pay, Grade, from Post of Loco Pilot Goods to Loco Pilot Shunter for a period of 5 years, increment will be granted in the lower grade during the penalty period. On expiry of the said penalty period, it will not postpone your future increment of pay, during the period of penalty you will not be considered for promotion to your original grade and you will not regain your original seniority on the expiry of the penalty (with loss of seniority). The period of Removal from service to re-instate to be treated as dies non."

"Therefore, your grade is reduced from Level-6 to Level-4. Pay from Rs 36500/- to Rs 25500/- and post from LPG to LPS as per 7<sup>th</sup> PC matrix for a period of 05 years, increment will be granted in lower grade during the penalty period. On expiry of the said penalty period, it will not postpone your future increments of pay during the period of penalty, you will not be considered for promotion to your original grade and you will not regain your original seniority on expiry of the penalty (with loss of seniority)"
