Sr. No. 02 has been issued with SF-5 on 09/11/2015 and imposed penalty of "Reduction to one Grade below from Level-6 to Level 5 in seventh pay commission fixing pay at minimum of pay i.e Rs 29200/- for a period of seven years with loss of seniority and postponing future increments (with cumulative effect) on 17/01/2017 by Disciplinary Authority. On appeal A/A has reduced the punishment as " Downgrading Reduction to one grade below to level five, fixing pay at minimum pay of Rs 29200/- for a period of FIVE YEARS, with loss of seniority and post-poning of future increment (cumulative effect) vide L. No. SUR/C/D&A/AAM/TTI/SUR/6/16 dated 12/06/2017.
