Employee is eligible to exercise an option within a period of one month for fixation of pay on promotion in the manner as laid down in RB's LtrNo.E(E)II/89/FR-1/1 dt.12/12/1991- Amendment to the IREC Vol.II(VI Edition 87). However they have already awarded higher grade under MACP scheme is not entitled for pay fixation his regular promotion as it is the same grade granted under MACP in reference to para 4 of annexure of Railway Board's letter no.PC-5/2009/ACP/2 dated 10.06.2009.

Transfer of a Railway servant, ordered as a result of his promotion should be carried out by the employee as early as possible in his own interest. In the case of an employee who neither gives the refusal in writing nor joins duty on being promoted, it should be treated as refusal of promotion and action taken accordingly. It is responsibility of controlling supervisor to inform the concerned staff accordingly and get it noted. Changes took place should be intimated to all concerned.
