The above named employees who have been awarded financial up gradation as above can exercise an option within one month from the date of issue of this Office Order under Rule No.1313(1)(a)(1) of IREC Vol. II (6th edition). On grant of financial up -gradation under the scheme, there will be no change in the designation, classification or higher status. However financial and certain other benefits which are linked to the pay drawn by an employee such as HBA, allotment of Government accommodation shall be permitted.

If it is come to the notice of Railway administration that the employee granted benefit under MACP scheme is not eligible to get the benefit due to any reason, the financial up gradation granted to such employee will be withdrawn.

Financial up gradation under the MACPs shall be purely personal to the employee and shall have no relevance to his seniority position. This Office Order is subject to condition that employees are not undergoing any effective punishment under DAR, Vig. and SPE cases.
