As per instruction of RBE No.195/2017 dated.18/12/2017 in appointment of candidates on compassionate grounds, it has been decided that such candidates who have passed 10th standard, but is not in possession of technical qualification i.e. National apprenticeship Certificate(NAC) granted by NCVT or ITI or courses/ Trade Diploma, the prescribed qualification for technical and commercial (catering) departments, viz., Civil Engineering, Mechanical, Electrical, S&T Departments and Commercial Catering level-1, may also be considered for appointment, providing them on job training for a period of six months.
