

If it is, come to the notice of Railway administration that the employee granted benefit under MACP scheme is not eligible to get the benefit due to any reason, the financial up-gradation granted to such employee will be withdrawn.

Financial up-gradation under the MACPS shall be purely personal to the employee and shall have no relevance to his seniority position. This Office Order is subject to condition that employee is not undergoing any effective punishment under DAR, VIG, and SPE Cases etc.
