
In terms of Para 4 of CPO/CSMT's Lr. No. P/CR/HQ/RP/601-Policy dt. 15.03.17, employees at Sr. No. 03 and 05 have been promoted against SC quota.

In terms of Para 4 of CPO/CSMT's Lr. No. P/CR/HQ/RP/601-Policy dt. 15.03.17, employees at Sr. No. 06 and 07 have been promoted against ST quota.

In terms of Para 03 of CPO/CSMT's Lr. No. P/CR/HQ/RP/601-Policy dt. 15.03.2017, Sr. No.08 & 09 will be promoted against UR quota & will be set off against ST quota in future.

Sr. No. 04, 08 & 10 are eligible for all facilities on transfer account.

Fixation of pay will be done as per extant rules on the subject. Above named employees are eligible to exercise an option within a period of one month for fixation of pay on promotion in the manner as laid down in RB's letter No. F(E)II/89/FR-1/1 dated 12/12/1991 Amendment to the IREC Vol. II (VI edition 87). However those who have already awarded higher grade under MACP scheme are not entitled for pay fixation on their regular promotion as it is the same grade granted under MACP in reference to Para 4 of Annexure of Railway Board's letter No.PC-5/2009/ACP/2 dated 10.06.2009. Option once exercised shall be final.



It is the responsibility of controlling supervisor to inform the concerned staff accordingly. The date of shouldering higher responsibilities of the employees should be advised to all concerned without fail.

The promotion is also subject to disposal of Writ Petitions/appeals/applications pending in Honorable Supreme Court/High Court or various CATs as the case may in occupation before carrying out the transfer/promotion order.
