As a result of screening for absorption of medically de-categorized staff in Group 'C' category Sr No 01 to 04 on medically de-categorization absorbed in Personnel department.

As per existing instructions/guidelines issued by Railway Board, seniority of Sr No 01 to 04 will be assigned in Ministerial Cadre, in Personnel department.

Sr No 01 to 04 will have to appear and qualify in the typing test within 02 years from the date of posting. Typing test will be of typing speed of 30 w.p.m in English or 25 w.p.m in Hindi. As per Railway Board's letter No. E(N)I-2015/CFP/7, RB/ESTT No. 02/2017 dtd. 16.01.2017 received under CPO/CSTM Lt. No. P/HQ/Ruling/O/803 dtd. 25.01.2017, It has been decided that instead of testing the typing skill on typewriters, the same may be tested on personal computers (PCs) at the speed of 40 w.p.m in English or 35 w.p.m. in Hindi.
