After gone through the Charged memorandum issued to Shri.Kiran Kadam .OS(P)PNM/SUR, relevant documents and DE,s explanation, the Disciplinary Authority (Sr. DPO/SUR) has imposed the penalty of "Removal from Service" vide penalty order dated 20.07.2021. On appeal ADRM/SUR & AA "upheld" the punishment imposed by DA vide order dated 08.09.2021.

The Revision petition dated 19/22-10-2021 Rule 24(2) of RS (D&A) Rules 1968, submitted by Shri Kiran Kadam, Ex OS(P)SUR, along with his DAR case file and other documents was put up to GM the appropriate Revising Authority for its consideration. GM the Revising Authority vide order dated 23.05.2022, has decided to reinstate him in Railway Service by modifying the penalty of Removal From Service to that of **Reduction to lower time scale of Pay/Grade/Post from GP-4200/- (Level-6) as Office Supdtt. to that of GP-2800/- (L-5) as Sr Clerk, fixing his pay at Initial stage of GP-2800 (L-5), RS-29200/- for a period of Two years, with future direction that this will have effect on his seniority and future increments. The intervening period from the date of removal from service to that of reinstatement in Railway Service shall be treated as dies-non.**
