- 1) Shri Kolekar Audumber Govind, ALP-I Level 4 is under going effective punishment of reduction to One stage lower grade pay from 2400 to 1900 for a period of Two years (NC) vide ADME/SUR's letter dated 29/06/2020. His pay has been reduced by one stage from 01/07/2020 and punishment will complete on 30/06/2022.

Employees at Sr No 01 & 03 are eligible for all facilities on transfer account. Sr No 01 & 02 will be promoted after completion of punishment.

In terms of Rly Board's letter No. 2004/M(L)/466/7101 dtd.31.08.2009, the procedure laid down regarding standardized system for Loco handling training to the ALP/Shunters before promotion as Loco Pilot Goods should be adhered. ALP/Shunters promoted as LP(Goods) should be kept under supervision of CLIs.

Fixation of pay will be done as per extant rules on the subject. Employees are eligible to exercise an option within a period of one month for fixation of pay on promotion.

. The above promotion order is provisional and subject to the conditions that there is no DAR/SPE/Vig case pending or contemplated or proposed to be initiated. If any of the above staff is under effective punishment under DAR/Vig. they should not be promoted and it should be brought to the administration immediately.

The above promotions are subject to outcome of Supreme Court/ High Court/ CAT decisions.


The promotion is also subject to disposal of writ petitions / appeals / applications pending in various courts as the case may be in occupation before carrying out the transfer/promotion order.
