

Fixation of pay will be done as per extent rule on the subject. Employee is eligible to exercise as option within a period of one month for fixation of pay on promotion in the manner as laid down in RB's Lr.No.F(E)II/89/FR-1/1 dtd.12/12/1991-Amendment to the IREC Vol.(VI Edition 87). However those who have already awarded Higher grade under MACP scheme are not entitled for pay fixation on their regular promotion as it is the same grade granted under MACP in reference to para 4 of annexure of Railway Boar's letter No. PC-5/2009/ACP dated 10.06.2009.
