Sr No 05 Shri A A Mulla TTI/SUR is eligible for Seniority & Proforma fixation from 19.11.2014 i.e at par with his Jr Shri H R kulthe CTI, who has been promoted as CTI vide OO No. 48/2014 dated 19/11/2014 and actual from the date charge taken over as CTI.

Sr. No. 10 Shri Shabbir Ahemad promoted as CTI/WD, his punishment is completing on 30/06/2022, therefore He is promoted w.e.f. 01/07/2022 or from the date of reporting if later on.

Sr.No.8,9,10,13,15 & 16 are eligible for all facilities on transfer account. Fixation of pay on promotion will be done as per extant rules on the subject. Employees are eligible for fixation of pay on promotion from the date of shouldering higher responsibilities. All the promoted employees are eligible to exercise option for fixation of pay within a period of one month. The date of shouldering higher responsibilities along with option for fixation of pay, if eligible, should be forwarded to this office immediately for timely fixation of pay. Who have already awarded higher grade under MACP scheme are not entitled for pay fixation on their regular promotion in reference to para 4 of annexure of RB's letter No.PC-5/2009/ACP/2 dated 10.06.2009. In terms of para 224 of IREM Vol I I i) The employee refusing promotion expressly or otherwise (i.e. that he does not give in writing his refusal but also does not join the post for which he has been selected) Such an employee should be debarred for future promotion for one year but not be transferred away from that station for one year if unavoidable domestic reasons exist.

All promotions shall be subject to outcome of the main SLPs and the contempt petition mentioned in the Railway Board's letter No. 2016-E(SCT)1125/8 dated 30/09/2016 (RBE No.117/2016) and as per instructions of HQ letter No.P/HQ/ Rulinf/O/817 dt.04/10/2016 and clarification of HQ's letter No.P/CR/HQ/RP/601-Policy dt.15/03/2017 and in terms of Railway Boards letter No.2018-E(SCT)I/25/9 dt.19/06/2018 circulated by CPO/CSMT vide letter No.P/HQ/Ruling/O/817 dt.21/06/2018.

If any one from above is under effective punishment under DAR the same should be brought to Notice of administration immediately and if any should not be promoted.
