Employee is eligible to exercise an option within a period of a month for fixation of pay on promotion as per extant rules. The date of shouldering higher responsibilities along with option for fixation of pay, if eligible, should be forwarded to this office immediately for timely fixation of pay. If any employee not carry out the promotion order or not submitted refusal for promotion it will be treated as deemed refusal and he will not be considered for promotion for a period of one year.

The above promotion order is provisional and subject to the conditions that there is no DAR/SPE/Viz case pending or contemplated or proposed to be initiated. The above promotions are subject to result of Supreme Court/ High Court/ CAT decisions.

The promotion is also subject to disposal of writ petitions / appeals / applications pending in various courts as the case may be in occupation before carrying out the transfer/ promotion order.
