6. SPECIAL PREVENTIVE MEASURES, IF ANY, TAKEN BY WAY OF ESCORTING OF GOODS, PARCEL, PASSENGER TRAINS, PATROLS DEPLOYED OR PICKETS POSTED -

Law and order being the state subject, it is statutory responsibility of the State Government to provide security to Railway system. State Government have formed a special wing namely Government Railway Police to prevent, register and investigate crimes on Railways. Close co-ordination with State Authorities is being maintained for providing effective security to passengers and passenger area.

Following precautionary measures is being taken to curb such incidence in future:

- (a) 12 (on average) mail/express/passenger trains running over this division are being escorted by RPF Pune Division.
- (b) Access control at important stations over this division has been tightened up with random frisking of passengers and passenger belongings in coordination with GRPs.
- (c) All IPFs of Pune Division have been advised to keep close watch on their respective stations and jurisdiction in co-ordination with GRP over suspicious person.
- (d) Escort party and on duty staff is also briefed by IPFs and Sub-Ordinate Officers for safety & security of passengers.
- (e) Regular coordination with GRPs/Local Police and Civil Authorities, having jurisdiction over Pune Division are being made.
- (f) Passengers are being made aware by making regular announcements through PA system and loud hailer during the arrival and departure of trains.
- (g) Banners / posters are being pasted on trains, railway premises and auto rickshaws for awareness of the passengers.
- (h) Regular announcement at railway station in three languages is being made to prevent incidents of drugging, cheating, robbery and theft.
- (I) On- Duty Staffs are advised to attend the General Coaches, while the train halts at station.
