HAND NOTE OF PUNE DIVISION

INTRODUCTION:

Pune Division was formed on 10.01.1996. Initially, the Division was started with jurisdiction over Lonavala-Pune Section only. With effect from 01.04.2003, Pune–Daund–Baramati Section (excluding Daund), Pune–Miraj–Kolhapur Section and Lonand-Phaltan Section were added which increased the jurisdiction to 531.18 routes Km. Entire jurisdiction of Pune Division falls under the State of Maharashtra and covers important districts of Pune, Satara, Sangli and Kolhapur.

Division has 72 stations in its jurisdiction under various categories, while Pune is categorized as NSG-1, Miraj and Kolhapur as 'NSG-3' category, 14 stations fall under SG-3 category,11 stations are NSG-5 category, 29 stations in 'NSG-6' category and in 'HG-2' category 7 stations and in 'HG-3' category 08 stations.

Ticketing activities are undertaken through 57 UTS which dispense unreserved tickets & reserved tickets are dispensed at 37 PRS centres. Besides this, 36 ATVMs at 17 stations have been installed. Pune Divn's average passenger footfall is 1,19,490, per day originating trains are 33.86 & per day passing trains are 47.71

Sugar, POL, Automobile and Military equipments are major items of outward goods traffic. POL is loaded from HPCL Siding, Loni. Sugar is loaded from Gurmarket, Miraj, Sangli, Karad, Satara and Baramati Goods Sheds. Cement, steel, fertilizers, salt, food-grains, bulk cement, Clinkers, Military, LPG and POL constitute for inward traffic. These commodities are handled at Khadki, Ghorpuri FCI Siding, Loni, Uruli, Patas, Sasvad, Phursungi, Satara, Karad, Bhilawadi, Sangli, Miraj and Gurmarket Goods Sheds.

Mahabaleshwar, Bhimashankar etc are famous tourist spots. Pune and Miraj are also a known destination for medical tourism.
