The following terms and conditions may kindly be noted:-

The Re-engagement will be valid for a period of one year from the date of engagement and will be extended time to time as per administrative requirements.

1. Retired staffs who have retired from Mumbai Division as well as from All Divisions of Central Railway and are from the same category and same department for which notification is issued can apply.
2. The re-engagement shall not be beyond attaining the age of 65 years. No re-engaged employee should continue in service beyond 65 years of age.
3. The Administration is at liberty to terminate the services of the re-engaged employees even before completion of his term in case their work/ conduct is found unsatisfactory by giving a notice of 7 days. The re-engaged retired staff should give a notice of 7 days before discontinuing his services.
4. The employees Removed/Dismissed/Compulsory retired as a result of disciplinary action or in review are not eligible for re-engagement.
5. The re-engaged employees are entitled only for monthly fixed remuneration i.e reducing pension from his/her last pay drawn, (i.e. Basic + DA) at the time of retirement. The monthly fixed remuneration plus full pension shall not exceed the last pay drawn at the time of retirement.

6. The Re-engaged employee will not be eligible for any kind of leave (like CL, APL, Sick Leave etc) for absence if any, appropriate deduction from salary/wages will be made from the monthly remuneration.
7. The re-engaged employees are not entitled for any other benefit or facilities except the monthly fixed remuneration.
8. The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
9. Re-engagement shall be subject to prescribed medical fitness for the relevant Category.
10. Suitability/Competency of the applicant shall be adjudged by nominated committee by the way of personal interview before their re-engagement.
11. The duty hours of the re-engaged employees would be 8 hrs duty or as required. The duty can be changed as per the requirement of works by the administration with weekly off for one day.
12. Since the duties are mainly pertaining to the jurisdiction of Mumbai Division, hence the re-engaged staff should have to reside in jurisdiction of Mumbai suburban area only.
13. Copy of any of the following documents should be attached with the application & it is mandatory.
 - a. Service certificate
 - b. Pensioner Identity Card
 - c. Pension Payment Order
14. The last date for submission of the application is **13.09.2024**. Staffs retired from Mumbai Division as well as from All Divisions of Central Railway desires for re-engagement, has to drop their applications in the prescribed format at Annexure A in the box kept in P/General Section, 2nd floor of this office on or before **13.09.2024**.
15. Kindly note application received after **13.09.2024** will not be entertained.


