



HISTORY AND PLACES OF INTEREST


SOLAPUR

Etymologically Sola+Pur (sixteen villages). More credibly, Sonnalgi, Sonalpur or Sonalipur as can be found in several inscriptions. Solapuri chaadars are renowned all over the country for their durability. A medieval fort and a 12th century Siddheshwar Temple built by Siddharama of Lingayat sect. A large lake dug by him for providing potable water to the pilgrims during Shravan Maas. A city of ~12 lac population. Great Indian Bustard Sanctuary at Nannaj 22kms from Solapur.




PANDHARPUR

The nine centuries old abode of Vitthal and Rakhumai (Rukmini) in black basalt on the banks of Bhima, also known as Chandrabhaga (half the moon). The 2'6" NG line between Miraj-Kurduwadi-Latur has been converted in BG and, Pandharpur-Kurduwadi section was commissioned for passenger traffic in 2001. The new station building is in keeping with the religious and spiritual nature of Pandharpur. To cater to such a huge congregation during the fares, 12 additional UTS counters are opened in the station apart from the PRS and 3 UTS counters. Pandharpur is 428km from Mumbai, 52km from Kurduwadi. Direct trains from Mumbai, Nizamabad, Latur etc.



TULJA BHAVANI

12th century temple at Tuljapur on Solapur-Osmanabad highway of Durga Bhavani, the ferocious aspect of Parvati, consort of Shiva, atop Yamunachala hill on the foothills of Western Ghat. Also known as Tulja Bhavani, one of the 51 Shakti Peethas. on the Solapur-Usmanabad-Jalgaon proposed alignment. In a metre high granite with 8 arms holding arms and the head of Mahishasura whom she slew at Mysore as per tradition. Fare on Gudhi Padva, Makar Sankranti and Navratra. Legend has it that Bhavani herself appeared before Shivaji the Great and gave a sword which made him invincible.



RAMLING

Built by an Agent & GM of Barsi Light Railway in 1907 on a hilltop, besides the Ramling station on the erstwhile Kurduwadi-Latur NG (2'6") alignment, in the middle of Yedshi-Ramling Wildlife Sanctuary. The section has been converted into BG and, opened for passenger traffic 2008. In the sanctuary, blackbucks, chinkaras, wolves, foxes, hyenas, deers, bears and hares etc and more than 100 varieties of birds are found. The forest is largely deciduous with Dhawad, Khair, Teak, Sandalwood etc trees. The rest house had fallen in disuse for decades. Revived recently, aesthetically, with due regard to its old-world charm. Now, a highly sought after getaway for the near and far, Railway-men and civil/police authorities. A "Ling" worshipped by Ram, hence Ramling, the site where Jatayu fought Ravana to rescue Sita. The Ramling temple is situated deep in a ravine.



AKKALKOT

Akkalkot taluka is bordered by South Solapur tehsil to the west and by Karnataka state on all other sides. Akkalkot is widely known for its association with Swami Samarth, held by his devotees to be a reincarnation of Dattatreya. His temple, located in Gogaon, is the main tourist attraction in Akkalkot. Swami Samarth lived for over two decades at Akkalkot, mainly at the residence of his disciple Cholappa, where his samadhi (tomb) and shrine are now located. The shrine complex, which is known the Vatavrush Mandir since it encloses the banyan tree beneath which the swami would preach his message, is the hub of devotions for his followers.



BHIGWAN

Bhigwan is a town on the border of the Ahmednagar, Pune and Solapur districts in the Indian state of Maharashtra. Bhigwan is famous for birdwatching, especially flamingo and wildlife photography. Place is also famous for authentic Maharashtrian spicy fish food. Special dish is kadak fish fry of chilapi. It is located on the Pune-Solapur Highway around 100 km from Pune on the backwaters of Ujani dam. The distance between Solapur and Bhigwan is 151 km. It is also known as mini Bharatpur. Ujjani Dam is constructed on the Bhima River. The water of the dam has created a shallow wetland and hosts many birds.



SALIENT FEATURES OF DIVISION

Solapur is one of the Division of Central Railway situated on Mumbai-Chennai route having 728.525 route kilometers. The jurisdiction is from Daund-Wadi, Kurduwadi-Latur Road & Kurduwadi-Miraj. This division plays the pivotal role of being corridor connection to West and South.

Civil Districts Headquarters: The Division covers 8 civil districts of Maharashtra State viz. Nasik, Beed, Ahmednagar, Pune, Solapur, Sangli, Latur, Osmanabad & One district of Karnataka i.e., Kalaburagi.

PCSC/RPF/CSMT has inaugurated the new office accommodation of DSC/RPF/SUR on 12.11.2014 which is newly allotted on exchange basis with Construction department and situated at 2nd floor near accounts office.

The office of DSC/RPF/SUR is provided with separate chamber for the use of DSC/SUR and ASC/SUR with adjutant room for confidential section and visitor room. Another Chamber is provided to IPF/DAW-I, IPF/DAW-II and IPF/PS Cell. The Establishment and Crime section has been provided with separate accommodation. A separate room has been provided for keeping settlement cases which are to be preserved as a permanent record. The record pertaining to DAR section has been kept in a separate room.

The facilities such as washroom and changing room have been provided to the staff working in this office. The newly allotted office accommodation is sufficient and having healthy atmosphere. The branches such as Passenger Security, CIB and Prosecution have been provided with separate accommodations at various places in the main building whereas the store branch is situated in the Barrack portion. 25. SUGGESTIONS OF DIVISION FOR SYSTEM IMPROVEMENT.

- 1- Staff strength of the SUR division after the shifting of all staff from the Daund to Manmand station is remain very dismal. Present crime trend and dacoity threat by local gangs specially paradhish in SUR division, It is very difficult to maintain safety & security of SUR division of 728 Kms. jurisdiction in present strength of 278(Sanction strength is 369) as per present crime trend and dacoity threat by Paradhish.
- 2- Present strength of division is 278 in which DSC office, crime and passenger cell, control room and DSC reserve and Solapur RPF post presently cadre is around 100 staff which is essentially required for the functioning of the divisional HQ. Hence only meagre 178 staff is available for the field duties of the 728 kms. If leave reserve Rest and other casualty calculated around 150 staff is available for the duty in 3 shifts, hence around 50 staff is available in each shift. Managing all the escorting and guarding of the Railway

property of the 728 kms. section is very difficult as threat perception about the dacoity by signal tempering in KVV-Bhigvan section is very high.

- 3- The sanctioned strength as well as present strength of SUR division need to be increased, as SUR division is prone to TOPB due to Paradhi gang and other criminals who commit crime in trains by signal tempering, which make it compulsory to deploy 02 staff each at every signal between KVV to Bhigvan stations (there are 20 vulnerable signal in this section). Solapur division is also crime prone area especially booked consignment, Petroleum from BTPN rakes etc.
- 4- If we compare jurisdiction, threat and staff strength we found that Pune div jurisdiction is 780 Km with sanction strength of 654, means 0.84 staff available per KM but in SUR div. only 0.48 staff is available per KM, whereas threat perception is much high in SUR Div.

26. SURKSHA SAMMELAN & GRIEVANCES: all those taking part in parade to be addressed.

- Staff grievances are being redressed by the superior officers by conducting Suraksha Sammelan during their visits to posts and outposts.

27. GENERAL COMMENTS : (About the working of the division)

- Single line track between Daund to Solapur has been upgraded to Double line track, thereby Robbery/Dacoity cases by Pardhi criminal while trains stopped for crossing have been reduced, however still this crime has not completely stopped as culprits sometimes use new modus operandi by signal interference or placing Red flag in the track. All out efforts are being taken jointly by RPF, RPSF and GRP personnel for prevention of crime by properly utilizing staff at black spots/signals.
- **Marathwada Rail Coach Factory (MRCF)** is located at a distance of 10 km from RPF Post Latur, wherein manufacturing & maintenance of Vande Bharat Trains shall be undertaken by the Technology Partner (viz. M/s JSC Metrowagonmash- Mytisch, Moskva 141009 Russian Federation). Although, the Internal Security of the Manufacturing Unit lies with the "Technology Partner" but security of the Assets of the Manufacturing unit will not be transferred to the Technology Partner and security of Assets of the Manufacturing unit will be the responsibility of the "Security Department" of Solapur/SUR Division, but there is no Sanctioned strength available for providing security of the Assets of MRCF and it is not possible to deploy the manpower of present sanctioned strength of Latur Post, which is upgraded from Outpost to Post in 2023 with bare minimum present strength of 13 staff against sanctioned strength of 19 RPF personnel.
- **Solapur-Tuljapur-Usmanabad Rail Link** work is on progress and Tuljapur is a famous shaktipeeth where large number of devotees are visited every year and after linking of Usmanabad to Marathwada passenger rush has been increased and there is a proposal for Solapur-Usmanabad-Jalgaon rail link. To provide better security to passengers as well as railway property and in view of future prospectus, Usmanabad RPF Outpost must be upgrade as RPF Post and new RPF outpost may be opened at Tuljapur.
