## **Goods Traffic**

✓ During month of June-25, 163 Rakes loaded in comparison 185 Rakes loaded in last year's corresponding month (11.89% decrease). Freight Revenue 38.40 Cr Decreased by -18.05% from last year's corresponding month's Revenue of 46.86 Cr.

- ✓ Originating loading of 0.510 million Tons was achieved against last year's loading of 0.546 million Tons (6.49% decrease).
- ✓ Loading of POL traffic at IOCL (Pakni) During the month of June25, 15 rakes of POL were loaded. Revenue generated: 2.64 Cr.
- ✓ 41 rakes of Clinker loaded in June-25 fetching Revenue of Rs. 11.99 Cr. against 40 rakes loaded in corresponding month of last year, fetching 17.55 % increased revenue from corresponding month of last year.
